

# REED'S INDOOR RANGE, INC.

## RANGE SAFETY RULES

1. No one is allowed on the Range under the influence or if suspected of being under the influence of alcohol, drugs or any controlled substance.
2. **EYE and EAR** protection must be worn at **ALL TIMES** on the Range.
3. **ONLY OPEN ONE DOOR AT A TIME** when entering or leaving the Range.
4. Firearms must arrive and leave the shooting station bench in a case or basket. **No uncased firearms** may leave the shooting station bench.
5. Load firearms at the shooting station bench and keep firearms **pointed downrange**.
6. No fast or rapid fire. Allow at least **3 SECONDS BETWEEN SHOTS.**
7. If a **misfire** or other **malfunction** occurs, keep the firearm on the bench **pointed downrange** and notify the Range staff. **DO NOT** leave the firing line with a loaded or jammed firearm.
8. Firearms must be kept **pointed downrange** at all times. If leaving the Range temporarily, leave all firearms on the firing line, unloaded with the action open and the muzzle **pointing downrange**.
9. All persons entering the Range will be charged accordingly.
10. Shooting at anything other than your own target is prohibited. No head shots for inexperienced shooters. Shots must be a minimum of 15 inches below the target hangers. Minimum size for targets is 24" X 21".
11. Damages to any equipment, including target hangers or rental firearms, will be billed to the shooter(s).
12. Wearing or drawing from a holster is prohibited.
13. Firearms are subject to inspection and approval.
14. Ammunition is subject to inspection and approval.  
**-NO STEEL CORE, STEEL SHOT, ALUMINUM OR STEEL CASED AMMUNITION.**  
-Allowable handgun calibers are .22 through .50. No pistols that are chambered for rifle cartridges.  
-Rifles chambered for handgun cartridges are allowed.  
-For shotguns, all gauges, buckshot, slugs and birdshot are allowed. **Shotguns must be fired from the shoulder.** Pistol grip only shotguns are NOT allowed.  
-Reed's Indoor Range and its staff shall not be held liable for any damages incurred from use of ammunition. Customer will resolve any issues with the manufacturer of the product.
15. Any brass being removed from the Range must be marked. Please notify staff during check-in.
16. Only ammunition purchased at Reed's Indoor Range will be allowed for rental firearms.
17. Any hazardous behavior or violation of the Range Safety Rules will result in **IMMEDIATE REPRIMAND** and possible **DISMISSAL** from the Range.
18. Comply with all instructions from the Range staff.
19. **NO REFUNDS FOR PARTIES EXPELLED FROM THE RANGE FOR SAFETY VIOLATIONS.**
